

General terms and conditions of use for the ePaper and archive (from 2008) of our specialist journals “All-in-one subscription” (as of: October 2018)

1. Registration and access data

1. Only subscribers to our specialist journals are entitled to become users. In order to access the ePapers of the current calendar year and the archive of the years from 2008, you must register/create a personal user account on abo.vulkan-verlag.de. The subscription number required for registration can be found on your invoice. With the registration, a personal Media Centre is set up. Registration will only be valid if you provide entries in all the required fields. As user, you are obliged to keep the password secret and not to pass this on to third persons. Should you become aware of any facts that indicate a risk that third parties have gained knowledge of your password or have used this, you are obliged to change the password immediately or to inform the operator about this without delay.

2. Use of contents and the rights of third parties

1. This online application contains various types of data and information which are trademark protected or copyright protected in favour of *Vulkan-Verlag GmbH*, or in individual cases in favour of third parties. Protected brand names (trademarks) are not specially indicated. The lack of such identification does not justify the assumption that the product names can be freely used.
